<u>Checklist</u>

- Enroll into 4HOnline for your project(s)
- Have possession and ownership of your animal(s) by May 15
- Go to beef, goat, &/or sheep weigh-in pre-fair
- Obtain Premise ID
- Enter animal ID into 4HOnline by May 15th
- □ Complete 4-H QLC or YQCA
- Enter animals into FairEntry by deadline on June 23
- Complete the Record Sheet and turn it in at the fair to your Barn Superintendent at check-in
- Go to beef, goat, sheep, &/or swine weigh-in at the fair

ANIMAL ENROLLMENT DUE MAY 15

Beef, Goat, Horse & Pony, Rabbit, Sheep and Swine members must complete **4HOnline** animal enrollment.

Poultry will need to turn in their paper enrollment to the office by June 15th. This is the only project that will turn in a paper enrollment form.

ANIMAL POSTERS

If you are planning to complete a poster instead of showing an animal, you will enroll your poster into FairEntry by June 23.

SHOWMANSHIP

If you are going to participate in Showmanship for your animal specie, you **must** enroll on FairEntry.

PREMISE ID

Required for Beef, Goats, Sheep and Swine Exhibitors

To apply for a Premise ID through the Indiana State Board of Animal Health (BOAH) go to their website, www.in.gov/boah or call (877) 747-3038.

OWNERSHIP/LEASING QUESTIONS???

Which animal projects allow leasing?

The only project in Benton County that allows leasing is **Horse & Pony**.

All other animal projects require ownership of the animals you will be showing.

Ownership requires that you have legal possession of the animal which includes money or labor exchanged for the value of the animal.

All 4-H members planning to exhibit livestock at the 2024 Benton County Fair are required to complete an in-person Indiana 4-H Quality Livestock Care training (\$3, sign up in 4HOnline) OR

Complete online YQCA training (\$12, sign up at yqcaprogram.org). You only need to complete one or the other. If you choose YQCA, you will need to email, mail or drop off your certificate by Monday July 8.

- Enroll in 4HOnline by May15th. When you complete your online enrollment please make sure the animal status says "Active."
 If it says "Incomplete" please enter all necessary information.
- 4-H Quality Livestock Care or YQCA
 Training is required to show at the Benton
 County 4-H Fair and Indiana State Fair.

GOAT

Goat weigh-in and tagging

Wednesday, May 8th, 5:00-7:00pm. You will need to bring your does & wethers to the fairgrounds to be identified and have tattoos checked. All wether goats will be weighed. Tattoos will be checked on all registered does.

- Enroll in 4HOnline by May15th. When you complete your online enrollment please make sure the animal status says "Active."
 If it says "Incomplete" please enter all necessary information.
- 4-H Quality Livestock Care or YQCA Training is required to show at the Benton County 4-H Fair and Indiana State Fair.

HORSE & PONY

- Enroll in 4HOnline by May15th. When you complete your online enrollment please make sure the animal status says "Active." If it says "Incomplete" please enter all necessary information.
- 4HOnline will ask for Animal Lease Agreement, Horse Vaccination Form, and two horse pictures with face and all four feet.

POULTRY

- Poultry enrollment forms are due by June15. Be sure to list all of your birds that you want eligible to show.
- NPIP Poultry Exhibitor Form
- Pullorum-Typhoid Blood Testing -Wednesday, June 19th from 5-7 p.m. at the Benton County Fairgrounds by the Poultry Barn.
- 4-H Quality Livestock Care or YQCA
 Training is required to show at the Benton
 County 4-H Fair and Indiana State Fair.

RABBIT

- Enroll in 4HOnline by May 15. When you complete your online enrollment please make sure the animal status says "Active."
 If it says "Incomplete" please enter all necessary information.
- Rabbit Tattoos Contact Barn Superintendent, Alex Ardapple or your veterinarian.
- 4-H Quality Livestock Care or YQCA Training is required to show at the Benton County 4-H Fair and Indiana State Fair.

SHEEP

<u>Sheep weigh-in and tagging</u> Wednesday, May 8th, 5:00-7:00pm

- Enroll in 4HOnline by May15. When you complete your online enrollment please make sure the animal status says "Active."
 If it says "Incomplete" please enter all necessary information.
- 4-H Quality Livestock Care or YQCA Training is required to show at the Benton County 4-H Fair and Indiana State Fair.

SWINE

- Enroll in 4HOnline by May15th. When you complete your online enrollment please make sure the animal status says "Active."
 If it says "Incomplete" please enter all necessary information.
- Please note, you will need to ear tag your pigs that are going to State Fair with 840-RFID Tags prior to May 15, and county only swine will use at least the ear notches that are required in 4-H Online.
- For ear notches, both ears must have notches to meet enrollment requirements.
 When enrolling swine on 4HOnline, we recommend you submit pictures of the ear notches of each ear. If you have any questions, feel free to contact the Swine Superintendent. Tags and taggers are available at the Extension Office. Please promptly return taggers, as we have a limited amount for everyone to use.
- Farrowing date is December 1st.
- 4-H Quality Livestock Care or YQCA Training is required to show at the Benton County 4-H Fair and Indiana State Fair.

2024 Indiana 4-H Animal Identification

The following table lists the different animal species and the respective form of identification that is required for a 4-H member to be eligible to show in the 4-H livestock shows at the 2024 Indiana State Fair. The animal ID information must be entered in the Indiana 4-H Online enrollment system by the respective deadlines. Missing, incomplete or incorrect animal ID information could result in state fair ineligibility for that particular animal.
