News for Everyone

4-HOnline enrollment & payment of program fees is due by May 15, 2023.

If you enroll May 1-15, you must use a major credit card for payment.

Note: some animal projects have an earlier deadline.

Fair Entry will open May 1-19, 2023

Failure to do so will result in those projects placing no higher than a blue ribbon (no honor, division reserve champion, division champion, State Fair Entry, reserve grand champion or grand champion).

Rules Book Available

We are asking for a 72 hour notice for pick up of manuals, poster sleeves, or materials. We do not have access to these storage rooms as freely as we use to. Thank you.

Add/Drop Deadline - May 15

Remember, you have until May 15, 2023 to add or drop projects on 4-HOnline. You **MUST** be enrolled in a project by May 15, 2023. This will make fair Entry easier for you. Drops not as important but the adds are important. Call the Extension Office if you have any questions.

Fair Entry is Due May 19, 2023. Think of Fair Entry as a RSVP for a class, pen, poster rack spot or a table spot for your project. Fair Entry is also where your project labels are configured from by the Extension Office. Fair Entry is to be completed by all in grades K-12. There will be a help session on May 17th from 5-8pm (open house style) for families who need help completing fair entry.

2023 Animal Deadlines

Please try to complete all enrollment in animal projects ASAP. We send information electronically to youth enrolled in specific 4-H projects. We cannot send you the information if you have not enrolled in that specific project. This will be important information on ID dates, 4HOnline deadlines, etc.

Premise ID

Do you need a Premise ID? Do you have livestock housed somewhere besides your place. Premise ID numbers can be applied for at the Indiana State Board of Animal Health.

Grooming Assistance at the Indiana State Fair

Just a reminder that if you are planning to exhibit at the Indiana State Fair you need to make sure that you are in compliance with the Grooming Assistance rule. 4-H Exhibitors may receive clipping and grooming assistance from members of their immediate family (father, mother and siblings), from a current Indiana 4-H Member; and from individuals enrolled in the Indiana 4-H Approved Animal Grooming Assistance Program. Temporary guardianships are not permitted and shall result in immediate disqualification. The Grooming Assistance application can be found at <http://bit.ly/animalgroominglist>. Please note that this program is only for Indiana residents and must be completed.



Transitioning from YQCA to the Indiana 4-H Quality Livestock Care Program

Indiana 4-H is transitioning away from the national YQCA program and creating our own Indiana 4-H Quality Livestock Care program for those exhibiting cattle, goats, poultry, rabbits, sheep and swine. Allen County dates for the Quality Livestock Care course:

Monday May 8, 6-7:30 pm @ the Allen County Extension Office on the PFW Campus

We need a RSVP so we have enough chairs set up and enough copies to hand out. Please email jkendall@purdue.edu to reserve that spot. **As per state, in-person sessions will cost \$3 per person at the door.**

National YQCA certificates will still be accepted in Indiana and can be completed online like in the past. So, you are welcome to attend one of the courses OR you may complete YQCA online. Both will be honored and accepted at the Allen County Fair as well as the Indiana State Fair. Some large livestock shows in other states are still requiring YQCA, so check with the show managers to determine what best suits your needs. If you do the National YQCA program you will need to acquire a certificate to prove completion. **Please email your certificate to Rebecca at rcclay@purdue.edu to ensure your requirement is marked complete in 4-H online.**

Ideally we would like you to complete the program by May 15. If you are in possession of the animal, you should have taken the class already.

If the Allen County dates do not work for your family, you may register your child for another county's QLC program on 4-H online. Within your child's profile find the events tab and click register for a new event. Select the county's program you want to attend. Once you click on the name of the event, it will allow you to see the dates.

Every member exhibiting cattle, goats, poultry, rabbits, sheep and swine has to complete one of the 2 programs or they cannot show their animal at fair!

Exhibiting Livestock at Fair:

This is a reminder to all members showing livestock at the Allen County Fair. **As per the rule book**, "All exhibits brought for judging **MUST** remain until the scheduled release." All projects will be released on Sunday 6/25 at 6pm. You must pick up your project on Sunday. If you have an animal that will be in the auction, those remain at the fairgrounds. "If projects are removed before being judged they cannot be returned to fair for judging. Early removal after being judged will result in the loss of awards in that project and the exhibitor's ineligibility to compete in that project in the following year."

Cattle, Horse, Llama, Swine, Sheep & Goat Animals identification must be entered in V2.4online by May 15.

Please read this important animal information for 2023. **Please review the table in the newsletter with updated Animal ID requirements. All Cattle, Horse, Llama, Swine, Sheep, and Goats must be in V2.4online on or before May 15.** DNA Envelopes must be back in the office's hand by 4:30 on May 15. The Indiana State Fair Entry deadline is July 1.

Ear Tags

Tag orders must have a 72 hour notice in order to be pulled. You can email jkendall@purdue.edu to request your tags. She will pull and let you know when you are good to pick up your tags. (No orders can be placed May 11 & 12 because Becca and Jean are out at Plant Sale Fundraiser). Not everyone in the office can pull tags so you must contact Jean.

Swine Members: Tags cost is \$5.00 each.

Beef Feeder Calves & Junior Heifers – Tags & RFID tags may be purchased by emailing jkendall@purdue.edu 72 hours in advance. These will not be available until after April 20. Cost is \$7.00 for the set of tags.

Goats/Sheep Your tags will be available April 20 at weigh in/tagging. Cost is \$5.00.

Identifying Animals in 4HOnline

Horses and Llama will be the only species requiring photographs in 2023. You will need to upload two images of your animals in V2.4online for verification purposes. The first colored photo will be of the animal's head showing all required tags in the animal's ears. The second colored photo will be a full body image showing all 4 feet and the head of the animal must be in the photo. If families need assistance in adding the photos in 4HOnline, please call the office at 260-481-6429. Additional detailed instructions for identifying each species in 4HOnline are located on the home screen of 4HOnline after logging into to your family profile.

2023 Indiana 4-H Animal Identification

The following table lists the different animal species and the respective form of identification that is required for a 4-H member to be eligible to show in the 4-H livestock shows at the 2023 Indiana State Fair. The animal ID information must be entered in the Indiana 4-H Online enrollment system by the respective deadlines. Missing, incomplete or incorrect animal ID information could result in state fair ineligibility for that particular animal.

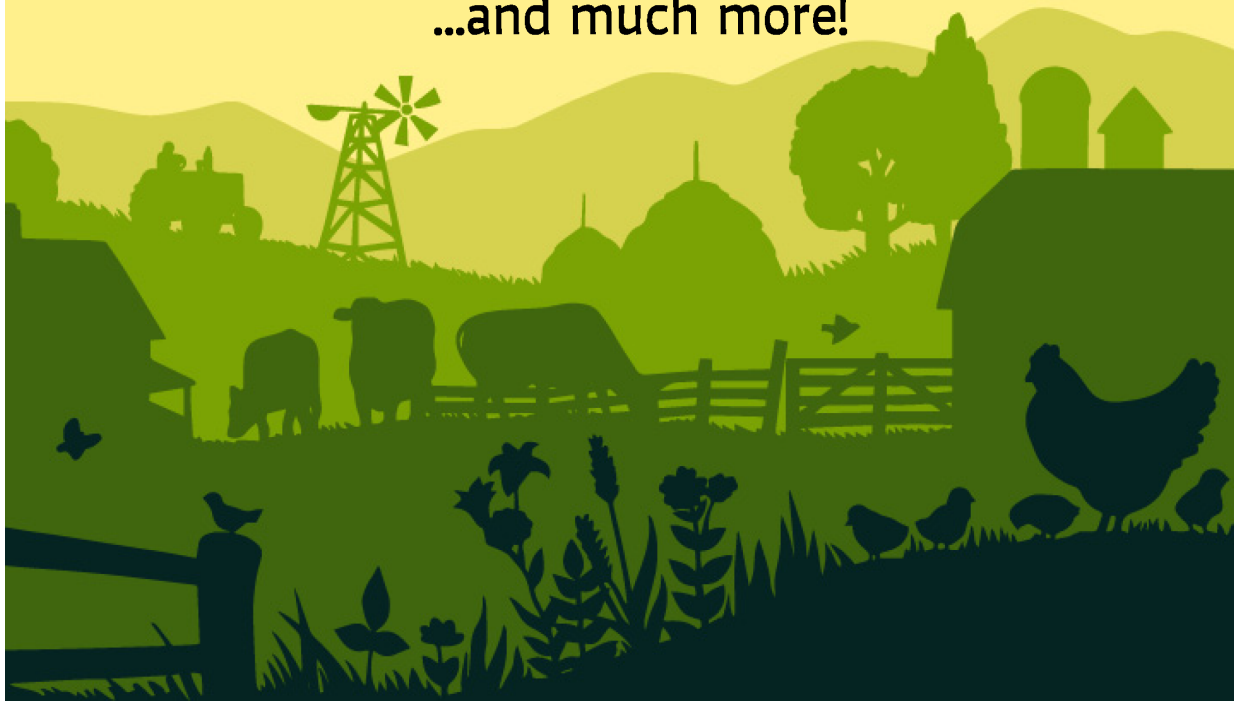
