# What needs to be completed by May 15th?

- All project changes should be made in 4-H Online no later than May 15th. You may add/drop projects from what you originally decided until then.
- Animal ID information MUST be entered into 4-H Online, excluding poultry.
- If you plan to exhibit livestock at the Indiana State Fair, DNA envelopes must be returned to the extension office by 4:00pm on May 15th
- Horse and Pony Vaccination Forms are due. Upload these into 4-H Online and submit a copy to the extension office or JC Riders Club Leaders.
- Seniors: Plain Dealer questionnaire and 4-H Scholarships are due to the extension office by May 15th.

# Attention Livestock Exhibitors

# To exhibit **Beef Cattle, Dairy Cattle, Swine, Sheep, Meat Goats, Dairy Goats, Poultry**, and/or **Rabbits**, 4-H

members must be certified through the Indiana 4-H Quality Livestock Care (IQLC) training **OR** the web-based Youth for the Quality Care of Animals (YQCA) program. This certification must be completed on an annual basis. The IQLC program will be offered as an in-person training in Jennings County on three dates prior to the 2024 Jennings County Fair. Members must register on 4-H Online for the training <u>before</u> attending.

# Animal ID and Tagging

4-H Members enrolled in livestock projects will receive a mailing with more information about Animal ID Day and requirements. If you do not receive the mailing a week before Animal ID Day, please contact the Extension Office. Refer to your livestock schedule for upcoming Animal ID dates.

#### Premise ID

Registering your premises may be done online, at no charge, and takes only about 5 minutes. Visit the Indiana State Board of Animal Health's (BOAH) website: http://www.in.gov/boah/2642.htm. Please get your Premise ID number before the tagging day! **To verify your premises ID, contact BOAH at email animalID@boah.in.gov.** All Indiana premises associated with the purchase, sale, and/or exhibition of cattle, swine, sheep, goats, and farmed cervids must be registered by state law.

#### Soil Sample and Testing:

The Jennings County Extension Office offers soil sample bags and test forms for sample submission. We have a soil probe available to borrow. Office hours are Monday-Friday, 8am-4pm.

# FECAL EGG COUNTS

UNIVERSITY

 A quantitative assessment and identification of the number of parasite eggs an animal is shedding at the time of sample collection

#### WHY SHOULD I GET A FECAL EGG COUNT ON MY LIVESTOCK?

Extension

 Fecal Egg Counts assess your livestock's parasite burden and target the parasite your livestock might be suffering from at the time of collection.

#### SAMPLE COLLECTION INSTRUCTIONS

- Use gloves to collect a fresh sample of feces from your livestock. The sample should still be both moist
  and soft. It should be collected and turned into the office no more than 6 hours from the time of
  defecation
- Collect at least 1/2 cup or 4oz. of feces and place in a clean ziplock bag.
- Label the bag with the species of livestock that the sample came from and the animal's identification.

FAMACHA CERTIFICATION PROGRAM

SMALL RUMINANT PRODUCERS & FOR 4-H MEMBERS AGE 13 AND UP May 15, 2024 at the Jefferson County 4-H Fairgrounds

FAMACHA© is a diagnostic test to help small ruminant producers identify animals that require anthelmintic treatment and those which do not require deworming. The tool is a card that matches lower eyelid color to anemia levels, an indicator of clinical barber pole worm infection.

This training is open to 4-H members and the general public. The event will be followed by a Indiana Quality Livestock Care Training (the required training for Indiana 4-H Livestock Exhibitors) so 4-H Families can get the most out of their evening. **Participants must be 13 years of age to receive the certification.**

For those new to the program, grant funds awarded from the IDOH will be used to purchase locally sourced fruits, veggies and proteins for special events with the Boys & Girls Club. Events will be held May-September 2024. A budget of approximately \$2500 per event will be used to purchase locally sourced fruits, veggies and proteins prior to each event. Over \$60K will go to our local growers and producers between 2023-2025!!
