Special Discussion: Fair opportunities. Pepsi Day will be Friday August 1st from 9-1. Volunteers are needed to man the Pepsi Day Booth. While it is expected that these will be primarily Junior Leaders, other volunteers are welcome also. About 6-10 volunteers are needed. The money from the recycled Pepsi cans is donated to the Junior Leaders.

Farm Bureau is seeking 4-H members to bring their animals to the Dairy Barn for 1 hour shifts between 3-7 from the first Friday of the Fair to the second Saturday of the fair. People may due multiple shifts. They can bring different animals or the same animal if they work different shifts. Farm Bureau will pay \$10/shift. 4-H members will talk to the public about the care, raising, and training of their animal. The animals brought must be easy to handle and people friendly. Farm Bureau will be doing a scavenger hunt in the barns and people will bring their completed entry forms to the area where the 4-H member will be with their animal to turn in their paperwork.
