#### Project/Notebook Requirements

**Intermediate:** You will be in the Intermediate division of this project for three years – grades 6, 7, and 8. Each year you will add a section to your notebook about the garments that you have purchased and the activities that you have completed. New record sheets will be given to you each year that you are in the project, but you will receive only one project manual per level.

#### **Exhibit Requirements:**

- 1. Complete a notebook. (40%)
- 2. Purchase a total outfit\* of 2 or 3 garments. Accessorize with items already in your wardrobe. (30%)
- 3. Model the outfit in the "Consumer Clothing" fashion revue. (30%)

\*Outfit: Garment or garments that when put together make a complete look. An outfit does not require additional garments in order to be worn.

#### Notebook:

Add information to the three-ring-binder that you begin in the Beginner Division of this project. Put the most recent year's information at the front. If this is your first time in this project, get a three ring binder and decorate it any way you would like. The notebook will be judged on the following items:

- 1. A title page:
  - a. Your name and Age
  - b. Project name and division (Intermediate)
- 2. Consumer Clothing record of Purchases page
- 3. Information gathered sheet Use a separate sheet for each of the garments that you have purchased for this project.
- 4. Photographs
  - a. One photo should show you wearing the garments as they will be modeled.
  - b. Two copies of this picture will be needed; one in the notebook and one not mounted to be turned in when the project is checked in. Another picture in the notebook should show the outfit with different accessories from your wardrobe; this demonstrates the versatility of your outfit.
- 5. Complete one activity from each group in the manual. Describe what you did for each activity and the results or findings. Write about each on a separate page. Label by group number and letter as they are in the manual. (For example, Activity Group 1-A) Each year you will select other activities from each group on which to report.
- 6. Complete the "Consumer Clothing Summary" form and include it in your notebook. Answer each of the questions completely. This is the opportunity to explain to the judge what you did in this project and why, as well as what you learned.

The "Consumer Clothing" Record Sheet (4-H 751) goes in your green record book. It must be signed by your 4-H Leader and turned in with your project.
