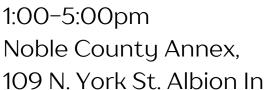

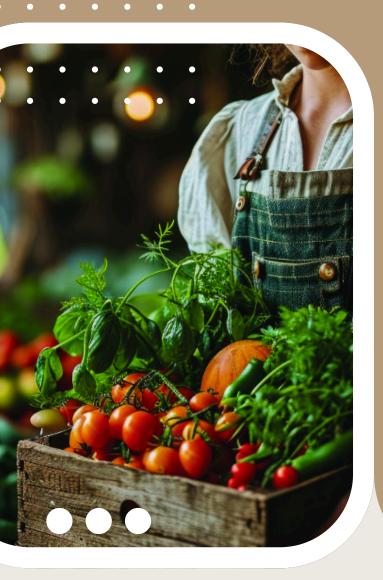

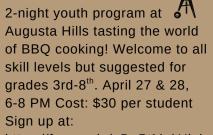

What is ServSafe Certification?

ServSafe certification means that you have obtained sufficient knowledge about food and beverage safety and handling to earn one of the certificates.

Who needs Food Manager Certification?

Retail food establishments in Indiana must obtain an ANSI-accredited Food Manager certification, such as ServSafe Food Protection Manager. Retail food establishments may include restaurants, food trucks, school cafeterias, hospitals, etc.

Who needs Food Handler Certification?

People who are serving and/or handling food and/or beverages outside of their home to people who are not their family or friends should take the ServSafe Food Handler course. Additionally, as of July 1, 2022, IC 16-42-5.3 requires that all home-based vendors obtain a food handler certificate from a certificate issuer that is accredited by ANSI. ServSafe Food Handler training fulfills this requirement.

Purdue University Office of Student Activities and Organizations (SAO) requires that when organizations plan to have self-prepared food served at an event, a ServSafe food handler be on site for food preparation and distribution.

Why Purdue's ServSafe Program?

Purdue University is recognized as a global leader in delivering education. We make science-based decisions based on data. Our historical data indicates that people have a much higher exam pass rate in our face to face ServSafe Certification trainings than those who take an online program. Most Indiana counties have Extension Educators who are trained to offer ServSafe training and certification exams. Check the calendars for ServSafe Food Protection Manager or ServSafe Food Handler to view upcoming trainings and locations.

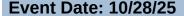
ServSafe educates food service workers about food safety.

ServSafe Food Protection Manager is their highest certification, and focuses on five aspects:

- Foodborne microorganisms and allergens
- Personal hygiene
- Purchasing, receiving, and storage
- Preparing, cooking, and serving
- Facilities, cleaning/sanitation, and managing pests

A photo ID with signature is required to take the exam (driver license, state ID, student ID, military ID, employee ID, U.S. green card, or valid passport)

Air-Fryer S'Mores Crescent Rolls

Total time: Prep-15min, Cook-10 min/batch, Yeild: 8 Servings

Ingredients:

- 1 Tube (8 ounces) refrigerated crescent rolls
- 1/4 cup Nutella, divided
- 2 graham crackers, broken up
- 2 Tablespoons chocolate chips

FINANCE & FARMLAND UNDERSTANDING CASH RENT

The Numbers

Cash rental agreements play a vital role for many farmers. For landowners who don't actively farm, leasing land to tenant farmers offers a steady source of income. Meanwhile, for farmers, renting land can be a cost-effective way to expand operations without the significant investment of purchasing property.

However, cash rent values are influenced by more than just number of acres. According to the 2025 Purdue Agricultural Economics Report (PAER), average cash rents for tillable land in northeast Indiana vary widely based on land quality. They recommend using an average of the past 3 years to determine average regional cash rents.

Due to low response rates, the survey has not reported hay and pasture land rental rates since 2021. Purdue put out an article and developed a spreadsheet to help determine grass hay and pasture lease rates (links on next page). According to the 2021 PAER, grass hay land rental rates across Indiana ranged from \$67 to \$132 per acre.

Another source for cash rent estimates is the USDA, which has historically reported lower values than those published in the PAER. For example, the USDA's 2020 Indiana Cash Rent County Estimates listed the average rent for non-irrigated cropland in northeast Indiana at \$170 per acre, compared to the PAER 2020 range of \$174 to \$242 per acre for the same region. In 2020, USDA reported Noble County's average rent at \$156 per acre—among the lowest in our region.

Why Does Cash Rent Vary?

Cash rent values fluctuate based on commodity prices, input costs, regional land demand, and local market conditions. Most reported rent values are averages; actual agreements often differ based on field-specific and relationship-based variables.

- Yield Potential. Fields with well-drained soils, high fertility, and a history of strong yields typically earn higher rents. Conversely, poorly drained or low-performing ground often rents for less. Proximity to natural areas—where deer, groundhogs, raccoons, and other pests are common—can affect yields and therefore decease rent value. Additionally, irrigated fields typically command higher rents due to their productivity potential (see PAER report for irrigated land data).
- Field Size and Shape. Smaller or irregularshaped parcels are less efficient to farm with modern equipment. The extra time and effort required to maneuver large machinery can reduce a field's appeal, lowering its rental value.
- Crop Type. Fields best suited for high-value crops like specialty vegetables or seed corn may command higher rent, especially if the tenant has a strong track record with those crops.

UNDERSTANDING CASH RENT (CONTINUED)

Why Does Cash Rent Vary?

(continued)

- Landowner Expectations. If a landowner requests specific conservation practices (e.g., no-till, cover crops, or buffer strips), or wants to retain certain features like old fence lines or natural areas, these preferences may influence rent agreements.
- Extra Services. Tenants who offer additional services—like snow removal, equipment help, or checking in on elderly landowners are not easily quantified, but build strong, long-term relationships.
- Investments. Tenants who invest in improving soil or infrastructure (e.g., liming, fertilizer, drainage) may negotiate lower rent or longer leases to recoup their costs.
- Location and Proximity. Fields located closer to a farmer's home base or other farmed land may carry a premium. Shorter travel distances reduce fuel and time costs and simplify logistics, making those fields more desirable.



Landowners Should Look for..

Renting farmland is more than finding the highest bidder. The long-term value of your land depends on management. Look at:

- Soil Health Practices. Farmers using cover crops, reduced tillage, and nutrient management strategies protect and enhance soil fertility.
- Crop Rotation. Rotating crops improves soil structure and reduces pest pressure.
- Neighbor Relations. A good farmer respects property lines, avoids spray drift, and maintains clean fence rows and field edges.
- Reliability. Timely rent payments, open communication, and a willingness to put agreements in writing are signs of a trustworthy tenant.

While many cash rent agreements are still made on a handshake, a written lease protects both parties. It should include length of the lease (annual or multi-year), payment terms and deadlines, allowed uses of the land, maintenance responsibilities, and termination clauses.

Whether you're a landowner or a farmer, successful lease agreements go beyond average rates. Each parcel is unique, and strong agreements are built on trust, clear communication, and good land stewardship.

The House passed the SB-1 on April 10 with a vote of 65-29. April 15, lawmakers in the Senate passed it by a 27-22 vote. Indiana Gov. Mike Braun signed the bill into law on the evening of April 15, 2025. SB-1 is legislation focused on property tax relief and local government finance reform. Here's a breakdown of its key provisions and impacts:

Property Tax Relief

\$300 Tax Credit: The bill would allow Hoosier homeowners to claim up to a \$300 tax credit. The tax credit would be worth 10% of a Hoosier homeowner's property tax bill, up to \$300, meaning Hoosiers that see property tax bills of \$3,000 or more would receive the full \$300 discount. The package offers a tax credit of 10% or a maximum of \$300 to every homestead.

Additional tax credits; stackable credits of \$150 for fixed-income seniors and up to \$400 for disabled veterans (\$150 and \$250 stackable credits for those who qualify).

Homestead Deduction Changes: Phase out the Standard Homestead Deduction by 2031. The standard homestead deduction will be gradually reduced, starting at \$48,000 in 2025 and phasing out entirely by 2030. Phase in a Supplemental Deduction equal to two-thirds of the assessed value (AV) of the homestead. The supplemental homestead deduction will increase from 37.5% to 40% in 2026, with annual increases to 66.7% by 2031.

New Assessed Value Deduction: Residential Non-Homestead Properties subject to the 2% circuit breaker credit will get up to a one-third AV deduction by 2031. The new deduction begins at 6% of assessed value in 2026 and gradually increasing to 33.4% by 2031. If property is located in a TIF district, adjustments may be made to base assessed value in an attempt to neutralize the impact of the changing tax rates.

Tax Deferral Program: Provides for a new property tax deferral program that can be voluntarily adopted by counties.

Agricultural land base rate Adjustment: The capitalization rate used to calculate the statewide agricultural land base rate has been amended, impacting how agricultural land is assessed for tax purposes. Per the state, farmers save roughly \$125 million over three years by increasing the capitalization/interest rate to 9%, reducing assessed value.

Legislation Affecting Deductions, Exemptions, & Credits:

On April 15, 2025, Governor Braun signed into law Senate Enrolled Act 1-2025 ("SEA 1"). SEA 1 converts a number of existing property tax deductions into property tax credits. All applications must be filed with the Auditor's Office by Jan. 15 of the year before taxes are due. For example, to receive a credit or deduction for taxes payable in 2026, an application must be submitted by Jan. 15, 2026.

SEA 1 eliminates several deductions, effective retroactively as of January 1, 2025. This means that, as of January 1, 2025, individuals will no longer be able to apply for these deductions and county auditors will no longer apply the deductions to property tax bills for the 2025 Pay 2026 cycle. The following sections of SEA 1 eliminate the deductions described below by stating that these deductions apply only to property taxes imposed for an assessment date before January 1, 2025.

Business Personal Property Exemption:

The Exemption Threshold: The Business Personal Property exemption threshold is currently \$80,000 in 2025. This threshold will rise to \$2,000,000 for the Jan. 1, 2026, assessment.

Phase-out of the 30% depreciation floor: The longstanding 30% floor for depreciated property will be phased out for equipment installed after Jan. 1, 2025. Notably, this change does not apply to property located within existing tax increment financing (TIF) districts.

The bill gives the opportunity to offset some revenue losses by restructuring Local Income Tax (LIT), raising the expenditure rate cap from 2.5% to 2.9% and allowing cities and towns to adopt their own LIT rate. The bill does shift some local tax burden from property tax to income tax as a matter of policy which will require difficult votes and local decisions in the coming years.

1.2% of the rate is reserved for general revenue for municipalities under 3,500 in population (distributed by population) o Allows municipalities over 3,500 in population to adopt a LIT rate up to 1.2% for general purpose revenue.

Debt and Excess Levy Appeals Summary Eliminates the excess levy 3-year growth appeals.

Provides a 1-year cooling off period for all short-term debt issuances under 5 years after they expire.

Provides that all municipal property tax debt-backed projects are controlled projects if the total debt service rate for the unit exceeds: o 0.25% for the remonstrance process o 0.4% for the referendum process.

Continues the 4% MLGQ cap in 2026.

Excess levy growth appeals are the only mechanism fast-growing communities have to attempt to right-size their property tax levies with their growing service costs.

Eliminating this tool means that fast-growing communities will only be able to rely on income tax increases to track growing service costs. More conversation with lawmakers on the importance of these appeals will be necessary.

The new controlled projects debt service rate threshold is relatively low and will capture more municipalities than under current law.

Limiting the rate impacts of debt from overlapping units, especially school corporations that issue the majority of general obligation debt in the state, may have positive revenue impacts by lowering rates and reducing circuit breaker loss.

Moves all referenda to general election years where they pass less frequently.

Budget Procedures Summary: Requires that public notice for the budget hearing must include the proposed increase in the tax rates and tax levies in proposed budgets.

Requires an additional public hearing prior to the budget adoption wherein the only item on the agenda must be the amount the tax rate and tax levy are increasing from the prior year.

Fire Territories Summary: Caps Fire Territory tax rates at 0.4%, Requires the county to approve all fire territory LIT distributions.
