Dear Parke County 4-H Horse and Pony Member,

2026 4-H Horse and Pony Enrollment: 4-H Horse and Pony animal enrollment must be completed in 4-H Online by **May 15**. The system will close after the 15<sup>th</sup> and NO animals can be entered after that time.

**4-H Horse and Pony Online Enrollment Steps:**

Enclosed you will find information instructions on how to complete your 2026 4-H Horse and Pony enrollment via your 4-H Online profile at [v2.4honline.com](http://v2.4honline.com). After you select “Horse”, you will be asked to complete each animal’s identification. Before you start your enrolment process, make sure you have taken and saved 2 color pictures of your horse to your device. The pictures must show the front of your horse’s head, their body and all 4 feet. During the animal enrollment, you will be asked to provide at least 2 pictures and this will allow you to easily browse and select your pictures. All Horse and Pony members **MUST COMPLETE AND PROVIDE THE CORRECT INFORMATION FOR EACH ANIMAL BY MAY 15<sup>TH</sup> TO SHOW AT THE COUNTY OR STATE FAIR!** Make sure all of your information is correct. Your animal is not enrolled until you have entered each animal’s information and picture.

**Horse Height:**

If you are not sure if your horse or pony is over or under 56 inches and you don’t have anyone to help you determine this, please contact Christina Hancock at 812-716-5060 or a horse and pony committee member to help you. Christina is the 2026 Horse and Pony Superintendent.

**Leasing Options: Lease Forms are due in the Extension Office by May 15th**

If you are leasing any of your horses or ponies, you will need to enter them online. However, for each horse you lease, you will need to complete a lease form and turn this form into the Extension Office by May 15<sup>th</sup>. I have enclosed one copy of the lease form. If you have more than one horse, please make copies. Please be reminded, leased horses can only be shown by the 4-H’er leasing the horse, siblings or parents between May 15<sup>th</sup> and the State Fair.

**4-H Horse and Pony Vaccination Forms (Required)**

The Indiana 4-H program requires a 4-H Horse and Pony Vaccination Form for each horse or pony that is enrolled in 4-H. Before you can bring your horse or pony to any 4-H activities, you will be required to show your 4-H Horse and Pony Leaders your completed 4-H Horse and Pony Vaccination form.

Once you complete the form, you can show this form to your 4-H Horse and Pony Leader and they will document for their records your shot dates for 2026. The rabies shot has to be administered by a vet. A vaccine clinic will be held at the Parke County Fairgrounds Wednesday, May 13<sup>th</sup> from 6-8pm.

**Required Vaccines: 5-Way \$28, Rabies \$15**

Voluntary Vaccines: West Nile \$22, Coggins \$40.25

**Horse and Pony Body Score**

You will also notice that the 4-H Horse and Pony Enrollment and Vaccination Form requests a Body Conditioning Score for all your horse and ponies. You can have your vet provide this or you can determine this score. Refer to the publication located on the internet at

<https://www.extension.purdue.edu/extmedia/AS/AS-552-W.pdf>. Healthy horses should fall between a 4 and 6 body conditioning score.

**Indiana State Fair Entry Form - (Make Sure You Read the State Fair Handbook to understand the entire entry and livestock qualifications. The book can be found via the Indiana State Fair website.)**

1. All entries must be made in accordance with the terms and conditions.
2. Online Entry - To enter into the Indiana State Fair, please go to [www.indianastatefair.com](http://www.indianastatefair.com) and enter online. Competitions > 4-H > Online Entry and follow the prompts. Each exhibitor is required to pay an entry fee at the time of entry. An exhibitor will not be considered entered into the Indiana State Fair until payment is made in full. Payment can be made online with a valid credit card.

**4-H Horse and Pony Club Project Requirements:**

If you ride your horse at the fairgrounds during a 4-H show or event, you are required to wear a helmet while mounted. Helmets need to be ASTM/SEI certified helmets.
