Winners

The judges will announce winners for each class, as well as an overall winner.

Guidelines for Contest

1. All entries must include peaches.
2. There is no limit on the amount of entries per participant.
3. Entries accepted: 10:00 a.m. – 12:00 p.m.
4. Entries will not be returned to the participant. They will be used as prizes for the cakewalk. *The cakewalk will be held as soon as judging is finished.*
5. Each entry MUST include a recipe card. The recipe card should include the following: participant name, ingredients and directions for the item you are entering.
6. There are 9 different classes you can enter entries in. They include:

- *Cake: 1 cake with or without frosting displayed on a flat surface*
- *Cookies: 13 cookies on a disposable plate*
- *Breads: 1 loaf bread; 1 fancy bread, 6 rolls or muffins all displayed on a flat surface*
- *Bars and Brownies: 13 bars or brownies on a disposable plate*
- *Jams, Jellies, and Spreads: 1/2 pint or 1 pint jar. *Jar will not be returned.*
- *Pies: displayed in a pie pan. *Pie pan will not be returned.*
- *Candies: 13 pieces on a disposable plate.*
- *Snacks: 1 quart-size plastic bag*
- *Miscellaneous*
