### <u>15– 4HOnline Enrollment Deadline</u> All Members

## 7- ID Day & Weigh In for Beef & Dairy Steers, 7 am on the Fairgrounds

All dairy & beef market steers must be permanently & individually identified in order to show at both the Brown County 4-H Fair & State Fair. Steers must be tagged on this day to meet the 4HOnline ID deadline.

### <u>14– Area 1 4-H Rabbit Workshop, 10 am–1 pm at Ripley County Fairgrounds</u>

## 15– 4HOnline Animal ID Deadline for Beef and Dairy Steers Beef

In order to exhibit cattle they must be properly identified in 4HOnline by this date. You will need:

- Tag Numbers- given at ID Day
- **Premise ID** given by BOAH
- Weight- Recorded on ID day

**Premise IDs** indicate where an animal originates in case a disease needs to be traced back to its source and are required by State Law. Obtain a Premise ID for your home or farm by going to <u>www.in.gov/boah</u>. Call the extension office for assistance.

### 3– 1st YQCA Opportunity, 6 pm in the Community Room

YQCA is a required training for all livestock exhibitors in 4-H. Training focuses on in depth topics re-



lating to animal care, ethics and responsibility. The training is free for in-person sessions with a coupon provided by the Brown County 4-H Council and \$12 to complete online. Reg-YOUTH TRE QUALITY CARE ANIMALS istration is required at yqca.org using 4Honline credentials.

## 3– ID Day for Goats, Sheep, Swine, Feeder Calves, Heifers, 2 pm @ Fairgrounds

The required IDs for each animals species are included in your 4-H Handbook. The following must be completed on or by ID Day

- Livestock ID Worksheet
- **Premise ID** obtained from BOAH .
- Animal Location Form- in Handbook, copies available
- Animal Lease Form- in Handbook, copies available (if the animal you are showing does not belong to you).

Planning to go to State Fair? If so a DNA hair sample and some additional IDs need to be attached to your animal at this date. Notify the extension educator prior to the event if you wish to exhibit at state fair.

## 15–4HOnline Animal ID Deadline

All animals except for rabbits, poultry, dogs and cats must be entered on 4Honline to exhibit. Poultry and Rabbits will be registered on Fair Entry in July. Use your Livestock ID Worksheet given at ID day to fill out 4Honline requirements Calves Heifers Swine Sheep Goats

To register your animals for exhibition you will need:

- Tag/Tattoo Numbers- given at ID Day •
- Premise ID- given by BOAH •
- Weight- Recorded on ID day
- **Birthdate**

Please complete this step by July 15th so we can prepare show bills for fair. Go to fairentry.com and login with your 4Honline credentials.

Animals will be subject to inspection by your 4-H Leader or Veterinarian before they can be unloaded. Make sure you have completed the following items before bringing your animals to fair.

- Complete YQCA Training
- Complete Animal ID on 4Honline before the appropriate deadlines
- Completed FairEntry
- Completed Animal Location Form at ID Day
- Completed Animal Record of Points at Livestock Check In

- Where: Located in the back of your <u>4-H Handbook</u>
- When's it due: Livestock Check In
- Livestock ID Worksheet
  All Livestock
  - What: List of your Animals IDs, premise ID and Birthweight
  - Why: To easily record ID information into 4HOnline and to practice keeping track of your livestock as a producer
  - Where: this form is provided at ID Day
- Animal Location Form All Livestock
  - What & Why: Records where your animal is located. Animal ownership and care is an important part of livestock production and 4-H project completion is not limited to the fair.
  - Where: Located in the back of your <u>4-H Handbook</u>
  - When's it Due: Animal ID day, Accepted till May 15th
- <u>Animal Lease Agreement</u>
  - Only needs to be filled out if you are exhibiting an animal you do not own.

Cat

- Where: Back of your <u>4-H Handbook</u>
- When's it due: May 15th to the Extension Office

## YQCA Completion Certificate All Livestock

- YQCA is a required expectation of all 4-H members in the state of Indiana to maintain our standard of quality and ethical animal exhibition
- Where: Can be printed from <u>yqca.org.</u>
- When's it Due: Before Livestock Check In, it can be completed any time. Does not have to be printed, only verified it has been earned.

Dog

- <u>Animal Vaccination Forms</u>
  - Species specific to Horse, Dog, and Cat Exhibitors.
  - Where: Joinindiana4-H.org , the extension office or your leader
  - When's it due: before you bring your animal onto the fairgrounds
