## 4-H LIVESTOCK ID/ENROLLMENT DEADLINE - July 1st

As we get ready for the next livestock ID/Enrollment deadline of July 1st, please review all of the identification materials sent by the Extension Office. There are help guides for each species at 4HOnline.com to walk you through the process. **If you have 4-H animals to enroll and you have not paid your 4-H Enrollment Fee, you must do so before you can add your animals online.**

**Animal ID Tags** have been mailed out to everyone who completed the Google Form or reached out to the Extension Office. If you still need tags sent to you, please contact us. If you need help tagging your animal, contact your livestock leader. **Reminder—Animal ID Tags MUST be paid before check in at the fair. If ear tag invoices are not paid by July 16, 2020 you will not be allowed to check in your livestock. Ear tags may NOT be paid for during check in.**

**Lease Paperwork** is due to the Delaware County Extension Office by July 1. If you need a copy, let us know! If you have any questions, contact the Extension Office. We are here to help!

## ADD/DROP PROJECT DEADLINE

The final date to drop or add a 4-H project is July 1st. If you need assistance with dropping or adding a project in 4HOnline, please call the Extension Office, 747-7732. 4HOnline will not allow changes after July 1st, so please make sure all changes are made prior to this date.

**DNA ENVELOPES NEED TO BE MAILED OR DROPPED OFF AT THE DELAWARE EXTENSION OFFICE BY JULY 1ST**



Youth for the Quality Care of Animals (**YQCA**) is a national multispecies quality assurance program for youth ages 8 to 21 with a focus on three core pillars: food safety, animal well-being, and character development. **\*YQCA certification is required by July 1 for all 4-H Members exhibiting beef cattle, dairy cattle, dairy goats, meat goats, sheep, swine, poultry, and rabbits at State Fair. Online trainings are available for \$12 per person.**

\*For 2020 only, Purdue is allowing counties to use an alternative educational option in place of YQCA. The 4 sections that must be completed are listed under the Online Animal Ethics Modules, which can be found here: <https://extension.purdue.edu/4h/Pages/Online-Animal-Ethics-Program.aspx> At the conclusion of the modules, youth will need to complete the Qualtrics link to obtain the accreditation. **If youth are planning to exhibit livestock in the 4-H shows at the Indiana State Fair they must complete YQCA.**

## ANIMAL POSTERS

If a 4-H member does not have opportunity to purchase or raise a livestock project this year, as an alternative they can make an Animal Poster for their species and receive credit for exhibiting their livestock project. They must follow poster board guidelines on page 45 in the fair book and enroll in the 4-H Animal Poster project on 4HOnline by July. The poster may cover a subject, and will be judged with the other Memorial Building projects. They must also complete their poster record sheet and turn it in with the poster at the time of judging.
