CONSUMER CLOTHING

LEVEL/GRADE:

Beginner – Grades 3, 4, 5 Intermediate – Grades 6, 7, 8 Advanced – Grades 9, 10, 11, 12

RULES:

- 1. Community Judging of all 4-H Consumer Clothing notebooks will take place prior to Fair at the Community Building. Please contact the Extension Office for this year's date.
- 2. Participants will take part in the Greene County 4-H Fashion Revue to be held prior to fair. Check with the Extension Office for dates.
- 3. Your purchases should be made as wisely and economically as possible.
- 4. It is essential to keep all receipts and hang tags for any purchased items including accessories to be included in your notebook along with your narration form for the Fashion Revue.
- 5. Keep each division's information in a notebook and add current year's information at the front of the notebook. If notebook is chosen to go to the State Fair, all previous years must be sent with the current year's project.
- 6. All notebooks must have a Title Page. Index page and tabs are optional. All notebooks must be able to accommodate 8 ½" by 11" notebook paper.
- 7. All posters, notebooks, and display boards must include a reference list indicating where information was obtained, giving credit to the original author, to complete the 4-H member's exhibit. This reference list should/might include web site links, people and professionals interviewed, books, magazines, etc. It is recommended this reference list be attached to the back of a poster or display board, be the last page of a notebook, or included as part of the display visible to the public. A judge is not to discredit an exhibit for the manner in which references are listed.
- 8. ***For personal safety concerns, notebooks exhibited should only contain name, county, grade, level and club. No personally identifiable information such as mailing address or phone number should be included.

EXHIBIT:

BEGINNER - EXHIBIT REQUIREMENTS:

- 1. Notebook which includes current year's report on the 6 activities completed, label pictures, sales slips, hang tags, record Sheets and previous year's information (except for first year members).
- 2. Complete one activity from each group in the manual. Write your results or answers in notebook. Label each activity. This will help you talk to the judge easily.
- 3. Help purchase an item of clothing that you'll wear with other clothes in your wardrobe. Examples might be slacks, blouse, jeans, shirt, sweater, or sweatshirt. Choose an accessory to go with your purchase. You might buy shoes, sweatband, belt, jewelry, or socks.
- 4. Model your purchases. Tell the judge about them, what you learned, and about the activities you completed. Take your manual and notebook with you because they will help you talk with the judge.

Intermediate - Exhibit Requirements:

- 1. Notebook which includes current year's report on the 6 activities completed, labeled pictures, sales slips, hang tags, record and previous year's information.
- 2. Complete one activity from each group in the manual. Write your results or answers in notebook. Label each activity. This will help you talk to the judge easily.
- 3. Purchase and accessorize a casual or school outfit. You may purchase accessories or select from items you already own.
- 4. Model your outfit. Tell the judge about your purchases, what you learned, and about the activities you completed. Take your manual and notebook with you because they will help you talk with the judge.

ADVANCED - EXHIBIT REQUIREMENTS:

- 1. Notebook which includes current year's report on the 5 activities completed, labeled pictures, sales slips, hang tags, Record Sheets and previous years' information.
- 2. Complete one activity from each group in the manual. Write your results or answers in notebook. Label each activity. This will help you talk to the judge easily.
- 3. Choose an outfit and accessorize it. You may purchase or select from items you already own.
- 4. Model your outfit before a group. Tell them about your activities in this year's project and how you plan to use this year's purchases in your future wardrobe. Take your manual and notebook with you because they will help you talk with the judge.
- 5. •If a member has completed all activities in the manual in prior years, the member is to consult with their extension educator, leader, or mentor to create an activity. When assembling the exhibit notebook be sure to include a note to the judge explaining how the activity was determined and the intended objectives.

STATE FAIR ENTRY:

One notebook from each division.
