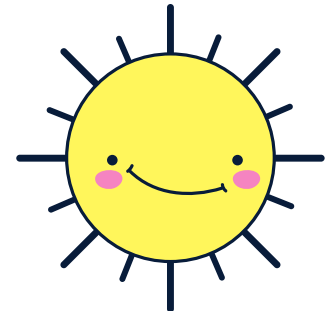

## Guidelines for Exhibition and Completion

The following are policies that govern exhibition and completion of 4-H Projects as stated in the Harrison County 4-H Handbook

**Exhibition:** The Exhibition of 4-H projects/subjects in local, county, or state exhibits/fairs is voluntary on the part of the exhibitor. The exhibition of 4-H projects/subjects provides 4-H members an opportunity to display their 4-H projects/subjects, enter into competition, and participate in an educational/social environment with peers. With exhibition also comes the responsibility for abiding by all the terms and conditions pertaining to the respective 4-H project.

**Completion:** The completion of a 4-H experience may include a variety of options and must not be misinterpreted solely as exhibition of a project at a local, county, or state fair. There are a number of ways that a young person may participate in the 4-H Youth Development Program in addition to the club-based option. Participating in these 4-H opportunities enable the youth to build skills that will serve them well throughout their adult lives.

Some of these participation options do not include the preparation of a specific exhibit by an individual that would be on display at a fair or similar event. In some cases, the youths' actual participation may be the final product that results in their completion of a year of 4-H. Some examples of this participation include working as a team to develop a robot for a workshop or challenge; completing a Spark Club experience; participating in State 4-H Band or Chorus; taking part in a science training or experiment; participating in an after school 4-H experience; etc.

**4-H members are considered complete in their 4-H educational experience for the year when they have**

1. Completed the 4-H member enrollment process prior to the established and published date for enrolling
2. Had an officially recognized 4-H volunteer/Extension Educator verify the existence of the completed project/subject or the member's participation in a 4-H educational experience.

Additionally, 4-H members who participate in a club- or fair-based 4-H project/subject will submit a completed **4-H record sheet** based on printed or web-based educational materials (used by Indiana 4-H Youth Development) prior to the established and published date. Though exhibiting in local, county, and state exhibits/fairs is not required for project completion, as it does not necessarily relate directly to content and skills learned in the development of the 4-H project, project exhibition is encouraged as a continuation of the educational experience.

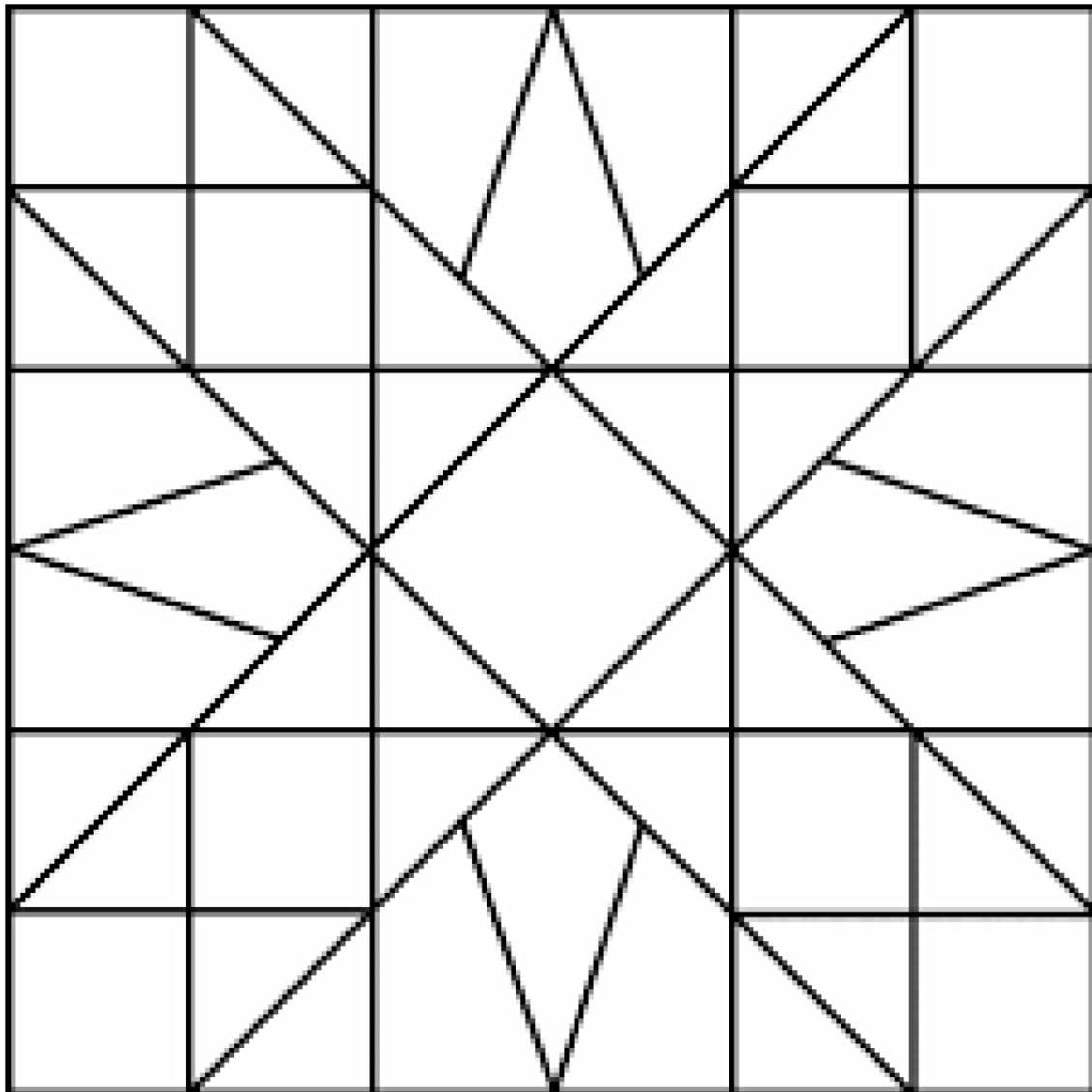

# Animal Identification

4-H Members (Grades 3-12) must identify all Beef and Dairy Cattle, Goats, Horses, Sheep, and Swine in the 4-H Online system by May 15th to be eligible for exhibition. Complete the following steps to identify your livestock on v2.4HOnline.com. Please contact your species superintendent with questions.

1. Login to your family profile at [v2.4HOnline.com](http://v2.4HOnline.com)
  - a. If you've forgotten your password, please use the 'Reset Password' option on v2.4HOnline.com and you will be sent a new temporary password.
  - b. If you've forgotten your email, please call the Purdue Extension Office.
2. Click "View" next to the Member's record from whom you would like to add an animal.
3. Click Animals in the navigation pane.
4. Click the blue Add an Animal button.
5. Click on Add New Animal to start adding a new animal.
6. Select the appropriate animal type from the drop down menu.
7. Enter the required Tag, Tattoo, or Animal Name and Click Save.
8. Read the instructions for Animal ID requirements for County Fair and Indiana State Fair Exhibition.
9. Click "Show Questions" after reading the instructions.
10. Required fields are indicated, but be sure to complete all other visible fields as applicable.
11. Click next once completed.
12. Upload any files necessary for the particular Animal type.
13. Click next once completed.
14. Once the entered information is correct and reviewed, click the Submit button.
15. The animal info will display on the screen with the status, created, modified, and submitted date and time stamp (local time). You will also receive a confirmation email upon submission.
16. To add more animals for the same member repeat steps 3-17. To add animals for another member return to the Member List and View another member.

Members are able to edit Animal ID information until the **Animal ID deadline** of **MAY 15**. Click on the Animals tab from your account at any time to view the status for all of the animals for a member of the family.

## YQCA

ALL youth participating in livestock projects are **REQUIRED** to complete the YQCA (Youth for the Quality Care of Animals) certification for project completion. The certification can be completed online (\$12) or in face-to-face classes (\$3). Test out options are available online only (not available for junior level). YQCA is an online based program and will require an online profile for certification. The Harrison County 4-H Council voted to purchase coupon codes for 4-H Youth members in livestock projects. Please check dates with your FFA advisor for additional offerings. Pre-registration is REQUIRED through YQCA.org.

# Premise ID

The Board of Animal Health (BOAH) requires premises registration of all sites associated with the sale, purchase, and/or exhibition of the following species: cattle, swine, sheep, goats, and cervids. Premise identification identifies a specific piece of property, not a specific animal. Try to imagine the animal's ear tag or tattoo being like the animal's "name tag", whereas the premise ID number is like the animal's "address".

## **Does every 4-H member need their own Premise ID?**

Not each 4-H member will need their own number. Premise ID numbers are assigned to a specific piece of property where animals are located. If multiple 4-H members keep animals on one premise, then the premise number will be the same for each of the 4-H members with animals residing at that location. Individuals who owns the property should register the premise; however, the person who owns or is responsible for the livestock should be listed as the primary contact for the premise.

# Companion Animal Vaccination Forms

Certificate of Vaccination forms for Cat, Dog, and Horse are available for pick up at the Extension Office. Forms will NOT be sent via US mail. Certificate of Vaccination forms for companion animals are also available at the State 4-H Website under the individual animal project page. See [extension.purdue.edu/4h](http://extension.purdue.edu/4h).

It is solely the 4-H member's responsibility to turn in completed ID and/or vaccination forms by the deadline. Completed health forms may be postmarked on the due date and mailed to the Extension Office, though this is NOT recommended, as mail is sometimes lost. An after-hours drop box has been installed outside the Extension Office front door for easy drop off. This box is checked each workday morning shortly before 8:00 am.

For forms to be valid, the form must be completely and correctly filled in, 4-H membership must be completed, AND the State fee paid. "Completed" ID worksheets and Certificate of Vaccination forms must include ALL required information. Forms will be considered incomplete and NOT accepted for enrollment if any of the required information requested in not provided by the project enrollment deadline. After the deadline, any form found to be incomplete will cause the 4-H member to be ineligible to be enrolled and participate in the project. It is the 4-H members responsibility to provide all required information on each form by the species deadline.

**Dog Vaccination Forms are due at the Extension Office by 4:30 PM, or postmarked by March 25th.**

# Animal Lease Agreement

Any animal exhibited must be shown and owned by the contestant, owned in partnership with the contestant's parent, stepparents, brother, sister, grandparents, legal guardian, or other family member. Dairy heifers, horses, and ponies may be leased subject to approval of the 4-H Youth Development Educator. Members must own or lease their horse by May 15. Animal Lease Agreement forms are available at the Extension Office or at [www.extension.purdue.edu/4h](http://www.extension.purdue.edu/4h) on the horse project page. Lease animals must be cared for by the 4-H member leasing the animal. The 4-H member and the member's immediate family should have exclusive use of the animal during the lease period.
