


## What is a Spark Club and how do I get involved?

#### **New Adult Volunteers**

Individuals expressing interest in becoming a 4-H Adult volunteer must:

## Minor Safety Training Operating Procedures for Programs Involving Minors

ALL Adult Volunteers MUST be up to date with their Minor Safety Training. As representatives of Purdue University, both paid staff and volunteers, we all have the responsibility to ensure the well-being of the youth in our programs. The training must be renewed every 24 months. To take this training online, go to **puext.in/VolTrain19\_20**. There will also be a inperson training available **January 14th** but it <u>must be completed in order for one to be an</u> approved volunteer.

## **Re-Enrolling Families**

www.4HOnline.com

Here are steps for Re-Enrolling your family with an existing 4HOnline Account. As always, we will have computers available in the office during business hours and we are happy to assist you. Please bring your email address and 4HOnline password. We do not keep records of passwords in the office.

- 1. Go to Indiana 4HOnline page at http://in.4honline.com using Firefox, Google Chrome, or Safari as your browser.
- 2. If you have logged into your 4HOnline account before and remember your password, log in to your account and skip to 18. Review and edit your Clubs if necessary. step #13.
- 3. If you have **never** logged in to your 4HOnline account before, contact the Extension Office to obtain the email address that is on file for your account. If you do not have an email address on file, contact the Extension Office to add the email address to your account.
- 4. Enter your email address and select "I forgot my password".
- 5. Select "Family" as your role.
- 6. Click "Send My Password".
- 7. Check your email account for your temporary password. Once you receive your password, select "I have a profile".
- 8. Enter the temporary password from the email message to the login page and Click "Login".
- 9. Once you log in, you will be prompted to create a new password. Enter a new password that you will remember.
- 10. Click "Continue" to go to your Family Member List.
- 11. The Member List will show all of the youth who were enrolled in the previous year.
- 12. Click "Edit" next to the Inactive member you would like to re-enroll.
- 13. To update your family information, click "Edit Family".
- 14. Scroll to the bottom of the record review page and click "Enroll for 2019 - 2020".
- 15. Update any personal information and Click "Continue" at the bottom of the page.

- 16. Read the Additional Information carefully.
- 17. Mark the check box and/or sign each section. This section will be locked for editing after the enrollment has been submitted. Then Click "Continue".
- Only Clubs in which the member will participate during the current program year should be listed. Click "Continue".
- 19. Review and edit projects as needed, then Click "Continue".
- 20. NOTE: Only projects in which the member will participate in during the year should be listed in the Projects tab. Previous year projects will remain on the Member's enrollment history. Remove any projects listed in which the member will no longer participate.
- 21. Groups is optional. Add any Groups in which the member will participate during the current program year, then Click "Continue".
- 22. An individual invoice is created for every Youth member and Adult Volunteer. Enrollment is not complete until the enrollment is submitted AND payment of any applicable fees is received. Click "Continue" to view your invoice, select a payment method, confirm payment and submit your enrollment.
- members and adult volunteers in your family 23. You will receive email notification that your enrollment has been submitted. You will also receive a second email notification when the County has reviewed and accepted your enrollment.

#### New Adult Volunteers Please Schedule an Interview First!

Individuals expressing interest in becoming a 4-H Adult volunteer must schedule an interview with Rebecca Wilkins, the 4-H Youth Development Educator, and visit the Purdue Extension Office in Harrison County to complete the paper application and screening process. Once the application and screening process has been completed and assigned a volunteer role by the 4-H Youth Extension Educator, adult volunteers can be added into 4HOnline.

- 1. Go to https://in.4honline.com and choose "I need to set up a profile". Select Harrison County.
- 3. Confirm your e-mail address.
- 4. Type in your household's last name.
- 5. Create your password
- 6. In the Role field select Family.
- 7. Click on "Create Login"
- 8. Choose your correspondence preference to either "Mail" or "Email".
- 9. Click on the "Continue" button at the bottom of the page.
- 10. In the drop down box under "Add a New Family Member", select "Adult" and click on "Add Member".
- 11. Complete each field in **BOLD**. These are required fields.
- 12. When you have completed this page, click "Continue." This brings you to the Additional Information Page.
- 13. All fields are **required**. Select an option if there is a choice, or check the "I garee..." box. 14. The authorization sections include Adult Behavioral Expectations, National and State Sex 28. Click the "Continue" button and Violent Offender Registry Check, Personal Liability Waiver, the Purdue University Vehicle Use Policy and Volunteer Required Signatures.
- 15. Double-check the transportation option that is selected is correct.
- 16. All fields must be filled in before you can click the Continue button.
- 17. Type your legal name in the membership signature box. This will serve as your electronic member signature.

- 18. By logging on with your login email address and password, you are indicating that you are the correct person to agree to the terms
- 19. When you have completed this page, click "Continue."
- 20. If you are a 4-H Club Volunteer, select the appropriate club from the list. Be sure to click "Add Club".
- 21. Add additional clubs if you have 4-H Club Volunteer responsibilities for more than one club.
- 22. Click the "Continue" button.
- 23. If you are a Project Leader/Volunteer under "Select a Project" click on the drop down menu and select the first project for which you have 4-H Adult Volunteer responsibilities.
- 24. "Years in Project" Select the number of years you have been a project leader for this project.
- 25. Select your role as a Volunteer for this Project
- 26. Click on "Add Project".
- 27. For each additional project that you are a volunteer, repeat the steps above.
- 29. If your assigned 4-H Volunteer responsibilities is to serve as a Committee Member, 4-H Council Member, Fair Board Member, or in an advisory role, click on the drop down menu and select the appropriate Group and Volunteer Type.
- 30. Once you have entered all your club(s), project(s), and/orgroup(s) you need to click on "Submit Enrollment" and you are done!

# YQCA Youth for the Quality Care of Animals

ALL youth participating in livestock projects are <u>REQUIRED</u> to complete the certification for project completion. ID info MUST be entered into 4HONline by the **APRIL 1st** state deadline.

NO Changes can be made after the APRIL 1st state deadline.

# Premise I.D.

# Why is a national animal traceability program needed?

A national system is needed to help protect American animal agriculture from foreign or domestic disease threats. Fundamental to controlling any disease threat is a system that quickly and effectively identifies individual animals or groups; the premise where they are located; and the date of entry to that premise. Identifying all food and livestock animals will enhance disease preparedness by allowing the U.S. to identify and locate any animals exposed to disease and will facilitate stopping its spread.

Is the premise ID program mandatory? Indiana state law requires premise identification for all sites associated with the purchase, sale, or exhibition of livestock in the state of Indiana.

What are the benefits for 4-Hers to participate in the premise ID program?

#### Frequently Asked Questions

Registration provides government animal health agencies essential contact information (name, phone number, address) for livestock owners. That data can be accessed in an animal health emergency to speed notification. Faster notification is essential to the rapid containment and control of disease. That translates into faster eradication and recovery from a potential economic disaster. Premise ID is especially useful for exhibitors. Exhibition livestock regularly commingle at fairs and shows; this can cause animals to be more susceptible to disease. Premise ID makes traceback of these animals much simpler.

# What species are included in Indiana's premise ID program?

Indiana's rule includes mandatory registration for cattle/bison, cervids, swine, sheep and goats. Poultry and aquaculture are also part of Indiana's plan. Although it is not mandatory,

equine and camelids may be registered voluntarily.

#### Do scrapie program flocks need to register?

Flock owners enrolled in the scrapie program will still need to enroll; however, enrollment will be more like updating your information. We need to be sure that, should an emergency occur, we have the contact information for the flock/herd, verified locations of the animals—the scrapie program only requires a mailing address, not physical locations of animals—and determination if the operation needs more than one premise ID number. We also need information on what other species, if any, are present on the sites.

#### What about my scrapie ID number?

The premise ID number to be assigned under this program will not replace or alter your scrapie flock or tag numbers. While we cannot say "never", we can tell you that for the immediate future, scrapie program participants should continue to use their flock numbers and tag their animals as they have been, regardless of the premise registration number.

#### What info will be collected in the database?

The info needs for registering a premise are little more than a phone book: Name, address and phone number(s) for primary and secondary contacts for the animals housed at each premise. General info on species and operation type are included.

**Is individual animal identification required?** Yes, for specific species. For more information go to BOAH's website at: www.in.gov/boah/2328.htm.

What about my 4-H tag, nose printing, etc.? 4-H ear tagging and nose printing are excellent tools to identify individual 4-H animals and will continue to be required in Indiana. However, premise identification identifies a specific piece of property not a specific animal. Try to imagine the ear tag or nose print is like the animal's "name tag", whereas the premise ID number is like the animal's "address".

What is a premise? And how do I know if I need more than one? Each state is establishing a

workable definition of a premise and guidelines for assigning more than one to a single animal owner. In Indiana, every animal site that has a unique 911 or postal address should have its own premise ID. Different numbers should also be issued for sites not contiguous within an operation. (Land separated by only a county road may be considered contiguous.) Facilities for animals at different stages of production (for example, calves, heifers, milking cows, etc.) may be one premise, if all are on the same piece of contiguous land. Only one number is needed when multiple species are on the same premise. The premise number is linked to a physical piece of property and will remain as such, regardless of ownership of the animals present.

Does every 4-Her need his/her own premise identification number? Each 4-Her will not need their own number. The numbers are assigned to a specific piece of property where animals are located. If multiple 4-Hers keep animals on one premise, then the premise number will be the same for each of the 4-Hers with animals residing at that location.

Who should register the premise? The individual who owns the property should register the premise; however, the person who owns or is responsible for the livestock should be listed as the primary contact for the premise. If multiple livestock owners house animals at one premise, the primary caretaker should be listed as the primary contact.

## Youth's Mental Health

Rebecca Wilkins, multiple 4H youth volunteers, and I had the opportunity to attend the Mental Health First Aid USA for Adults Assisting Young People course at the Clark County Fairgrounds. This certification allows for specialized training to provide care for young people experiencing depression, anxiety, psychosis, and substance abuse disorders. There was a particular focus on recognizing when someone may be experiencing crisis.

A little background on myself; I am first a wife and mom to five wonderful kids. Four of our children fit into the age group we were educated on. Secondly, I am a youth leader at Unity Chapel United Methodist Church, where I minister to children preschool through fifth grade. Third, I am an Emergency Nurse Practitioner, where I regularly see adolescents and young adults who struggle with managing their mental health well-being. Lastly, I am a volunteer for Harrison County 4H. This course has benefited me in many ways.

The founders of this program, Betty Kitchener and Anthony Jorm set out with the vision to create "an empowered community providing support to one another in times of mental health problems and mental health crises" (Kelly, CM, Kitchener, and Jorm, 2017). I commend them for setting out on this mission. The days of living in silence with the heavy burden of mental illness are coming to an end. Our youth need to know that it is okay to have a bad day

and there is someone to listen without interruption, judgement, or criticism. Establishing that the youth has that good support system in place, whatever that may look like; church leaders, mentors, teachers, school counselor, parents, friends, and/or family is imperative. It is well-known and often observed that opinions vary on the topic of mental health. It is best to be open-minded, non-biased, and supportive regardless of your personal feelings. Here is a helpful mnemonic: A-assess for risk of harm or suicide. L-listen non-judgmentally. G-give reassurance. E-encourage appropriate professional help, self-help, and other support strategies (Kell, et. al., 2017).

As a clinician, I try to instill in my patients that mental well-being is just as important as physical health. I often give the analogy that if they had a broken bone, I would not just give crutches to keep the weight off but additionally apply a splint to support the broken bone. To maintain good mental health often medicine in combination with counseling, behavioral modifications, and physical well-being are vital. It is also important for youth and their parents to understand that this transition to recovery does not miraculously occur overnight. It takes weeks if not months





for the efficacy of medicine to be noticeable and lifelong skills of coping mechanisms that depending on the individual and their motivation as to how long those develop.

Among the resources available to troubled youth and parents, a particular one I have found to be interesting is the Bark mobile app. According to Zapal (2019), 62.2% of tweens and 70.5% of teens either bullied, were bullied, or witnessed bullying on their electronic device. According to Curtin and Heron (2019), suicide increased 56% from 2007-2017 amongst youth aged 10-24. That is quite hard to swallow. How many of you have or love a child between the ages of 10 and 24? This app offers a way for monitoring your child while giving them the opportunity to maintain their privacy as well as prove that they are making good choices. The Bark app navigates through the digital platforms of text messages, email, social media for signs of unsafe content and conversation. When the app detects these potential risks, an alert is sent to the parent's device with a snapshot of the conversation in question. This app is also affordable at \$9/month for unlimited devices. The ratings from parents are very favorable. The deciding factor for me was that this app was designed based on evidence by psychologists, law enforcement, digital media experts, and youth advisors.



I leave you with this message: please, help a child in need. They are troubled, scared, and embarrassed; they probably won't ask you. It is your duty to say, "Are you okay? What can I do to help you?
