On-Line Exams for Private Manure & Chemical Applicators (PARP)



Due to decisions by the Office of Indiana State Chemist (OISC) who issues pesticide and fertilizer licenses for Indiana, there are no longer regional private applicator exams for farmers wishing to test for private pesticide or fertilizer (manure) use. Instead, farmers can either attend in-person exams and training at West Lafayette, or take exams through one of several computer host sites throughout Indiana (the nearest are at Ivy Tech. College in Evansville and Bloomington).

To sign up for on-line exams through Ivy Tech, you must register for an account at <http://indiana.metrosignup.com> . After setting up an account, you can then sign up for any exam needed. The entire process takes only a few minutes and can be done entirely on-line. The charge for use of the Ivy Tech facilities and staff is \$50.00 (there is no fee for the OISC exam, but you will be charged \$20.00 for the license after you pass the test). To schedule and sign up for the private applicator exam you can do so at: <http://indiana.metrosignup.com> , or by phone at (877)533-2900 (leave a message for staff to get back with you).

Each exam is a multiple choice exam taken from the pesticide applicator core or private Category 14 fertilizer manuals, and each takes approximately 60 to 90 minutes to complete. ANR News in-brief items for your consideration... (cont.)**Summer Horticulture Calendar****Lawns, Tree Fruits, Landscape Plants, and Woody Ornamentals****July**

- Keep newly established plants watered during dry weather. Allow water to penetrate deeply into soil rather than sprinkling frequently and lightly.
- Apply mulch around young plants to help conserve soil moisture and control weeds.
- Do not plant bare-root or ball-and-burlap stock at this time of year. Container-grown plants still may be planted, but only if you can keep them well watered.
- Continue a fruit tree spray program to keep diseases and insects under control.
- Remove water sprouts (sprouts from the trunk) and suckers (sprouts from the roots) from fruit trees.
- For those fortunate growers who have a good crop this year, prop up fruit tree branches that are heavily loaded with fruit.
- Pinch off faded rose blossoms. Continue rose spray program to control insects and diseases.
- Many Indiana trees are plagued by “lawn-mower blight.” Be careful to avoid nicking tree trunks while mowing.
- When watering lawns, apply 1 to 1.5 inches of water in a single application per week. Frequent, light sprinklings will encourage roots to stay shallow, making them more susceptible to drought.
- Bluegrass is a cool-season plant and is under great stress during hot, dry summers. If water is not applied, the bluegrass will become dormant and will turn brown, until more favorable conditions arrive in autumn. For extreme dry conditions, rescue watering is required to keep the plants alive, while still dormant. Apply one-half inch of water every 2-4 weeks.
- Mow grass one-half inch higher than usual during the dry, summer months to help conserve soil moisture. Do not mow when lawn is under severe drought stress.
- Don't remove clippings from the lawn unless grass is excessively tall or weedy. Clippings return some nutrients to the soil and do not add to thatch buildup.

Flowers, Vegetables and Small Fruits**July**

- Plant frost-tender plants after danger of frost has passed for your area. This includes warm-season vegetables such as tomatoes, peppers, eggplant and vine crops as well as most annual flowers and tender perennials, such as cannas, gladiolus, dahlias, tuberous begonias and caladiums.
- Pinch chrysanthemums and annual flower plants to keep them compact and well-branched.
- Make successive plantings of beans and sweet corn to extend the season of harvest.
- Thin seedlings of early-planted crops such as carrots, lettuce, spinach and beets to their proper spacing.
- Harvest early plantings of radishes, spinach and lettuce.
- Harvest asparagus by cutting or snapping spears at or just below soil level.
- Harvest rhubarb by cutting, or grasp the stalk and pull it up and slightly to one side.
- Control cucumber beetles, carriers of bacterial wilt, as soon as cucumber plants germinate or are transplanted to prevent disease.
- Remove blossoms from newly set strawberry plants to allow better runner formation.
- Remove unwanted sucker growth in raspberries when new shoots are about a foot tall.

Indoor Plants and Activities**July**

- Watch closely houseplants that have been set outdoors. They need more water than they did indoors. They can dry out rapidly in hot, summer breezes.
- Propagate houseplants by taking cuttings from vigorously growing plants. Place cut end in rooting media, such as perlite, vermiculite or peat moss soil mix. Enclose in plastic, and keep out of direct sunlight.

This disposal service is free of charge up to 250 pounds per participant. Over 250 pounds there will be a \$2.00 per pound charge. This is a great opportunity for you to legally dispose of unwanted products at little or no cost.
- WHO:** All public and private schools, golf courses, nurseries, farmers, ag dealers, cities, towns, municipalities and county units of government or others receiving this notice are eligible to participate.

- HOW:** Complete the enclosed **Pesticide Clean Sweep Planning Form** to the best of your ability. Then bring your labeled, leak free and safe to transport containers to the collection site. **DO NOT** mix materials. In case of an emergency, you should bring with you a list of products you are carrying and a contact phone number.

***NOTE:** OISC reserves the right to cancel this Pesticide Clean Sweep Project if there is not adequate demand. Participants submitting the enclosed planning form by August 6, 2021 will be contacted immediately if cancellation is necessary.

Dicamba Highly Volatile Herbicide Application Cutoff Date

The Office of Indiana State Chemist (OISC) would like to remind all agricultural applicators that there is a June 20th cutoff date for applications of most ag related dicamba products in Indiana. On March 2, 2021, the Indiana Pesticide Review Board (IPRB) voted unanimously to classify all Restricted Use Pesticides (RUP) containing more than 6.5% dicamba as Highly Volatile Herbicides (HVH). This HVH determination was made to allow for the establishment of a June 20th application cutoff date in Indiana again in 2021.

A HVH is defined in state law as any herbicide capable of emitting vapors that may cause serious injury to desired plants by reason of movement of the vapors from the area of application of the herbicide to areas inhabited by the desired plants. The IPRB has determined that dicamba herbicides used in agriculture during periods when many non-target plants and crops are actively growing and particularly sensitive to low levels of dicamba exposure meet that definition.

The list of HVHs includes all herbicides containing more than 6.5% dicamba active ingredient and classified as a Restricted Use Pesticide (RUP) in Indiana. In addition, the HVH determination will prohibit the application of all dicamba RUP herbicides to all crops for the period **June 21st through August 31st**.

Agriculture Resource: 24-Hour Emergency Spill Line

We're here to help YOU!

INDIANAPOLIS - Spring planting season is here, and it is important to be prepared for accidents and emergencies that can occur on the farm or on the highway. Because farms manage a variety of chemicals including pesticides, fertilizers, oils, and fuels, proper management of these materials can prevent potential hazardous spills from occurring.

"It is important to call the Indiana Department of Environmental Management's (IDEM) 24-Hour Emergency Spill Line at 888-233-7745 if a spill occurs on the farm," said IDEM Commissioner Bruno L. Pigott. "We have a team of professionals who are equipped and ready to assist landowners who experience a spill."

Indiana Code defines a spill as "[a]ny unexpected, unintended, abnormal, or unapproved dumping, leakage, drainage, seepage, discharge or other loss of petroleum, hazardous substances, extremely hazardous substances, or objectionable substances. The term does not include releases to impermeable surfaces when the substance does not migrate off the surface or penetrate the surface and enter the soil."

The early reporting of spills can save landowners hundreds if not thousands of dollars in fines and environmental mitigation costs. Owners and operators of facilities and modes of transportation are required by law to report all spills, including what was spilled and the total amount spilled. All spills require a spill response, and timely reporting is critical.

"If you have a spill, your quick actions during the first minutes can make a difference in the spill being contained or entering the waters of the state. If you can contain the spill, and keep it out of water, then the cleanup becomes easier and cheaper," said Fred Whitford with the Purdue Cooperative Extension Service. "Ultimately, we have an obligation to report a spill to IDEM to meet our legal responsibilities, but more importantly, to get help with the response."

"Farmers and farm retailers take many precautions to protect and enhance our environment and the land they farm. But, during this busy season, spillage accidents of fertilizers or other chemicals can unexpectedly occur," said Director of the Indiana State Department of Agriculture Bruce Kettler. "If you experience a spill of crop protection products or fertilizers, immediately contact IDEM's Emergency Spill Line."

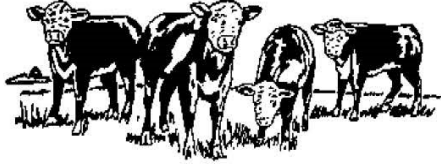
