OPEN CLASS RULES AND REGULATIONS

1. Rules and regulations must be followed as stated or exhibits will not be accepted at check-in. Several changes have been made to this exhibit guide so please read and follow these rules.
2. Open to anyone, not just Marshall County residents, who are not participating in 4-H.
3. Articles for exhibit must have been completed in the last three years, not previously exhibited at the Marshall County Fair, and made solely by the exhibitor unless otherwise stated.
4. Food Preservation items must have been preserved within the last 12 months.
5. Exhibitors may enter as many items as you like, however, some departments and sections have limited entry numbers.
6. Items must be placed in the appropriate category. Miscellaneous categories are for items that do not fit in any other specific category. Superintendents may change an item's category if they deem it more suitable for another.
7. Your items will be handled with care; however, Marshall County Fair is not responsible for items that are damaged while on display during the fair.
8. Entry sheets and score sheets along with the judge's comments will be placed in a locked file until exhibits are released.
9. No item can be entered with a "For Sale" sign or price tag on it.

The closed judging for all departments will take place on Friday, July 15, 2022 at 9:00 am.

Exhibits may be viewed starting Saturday, July 16, 2022 at 12:00 noon.

■Salon Print

Minimum image area of 8" x 10" to a maximum of 16" x 20" printed horizontally or vertically. The print must be mounted on a standard 16" x 20" salon mount, foam board displayed VERTICALLY and covered with plastic. Salon plastic sleeves can be purchased at the Extension Office at a minimal cost. No matting allowed.

■Multiple Prints

From 2 up to 10 pictures, 4' x 6' or 5' x 7', printed horizontally or vertically. The prints must be mounted on a background board 22" x 28", displayed HORIZONTALLY, with stiff backing and covered with plastic.

Foods

■ **For food competitions:** Filling, frosting, glazing, pie filling, and meringue, (whether uncooked or cooked) are not permitted to contain cream cheese, sour cream, heavy cream, whipped cream or half-and-half as the nature of these products increases the moisture content and water activity of the food. Foods with a higher moisture content and water activity can be ideal growing conditions for food borne pathogens, even if the ingredient is part of a batter and baked. Additionally, raw milk, raw milk products or uncooked eggs/egg whites are not permitted. Eggs/egg whites that have been cooked to 160 degrees F (i.e. pasteurized or included as part of a batter and baked) are acceptable. No home-canned fruits, vegetables, or meats are permitted in products. Recipes must be provided that show which ingredients were used in each part of the product. Contestants should carefully wash their hands and make sure that their hands do not have any open cuts before preparing foods. Contestants should not be preparing food exhibits for competition within 48 hours of recovering from any illness. Whenever possible, baked products should be transported and stored in chilled coolers (41 degrees F).

■ **Judges and individuals** who will consume products from county and state competitions should be informed that they are at risk for foodborne illness since the established policy cannot guarantee that an entry which may be a "potentially hazardous food" has been properly prepared or handled before, during or following the competition. Tasting of a food product is solely at the discretion of the judge. Judges are **NOT** to taste any low-acid or acidified preserved food, like green beans or tomato products, and are discouraged from tasting any other home preserved food. Consumers of competitive food exhibits being sold at auction or used for hospitality purposes should be notified they could be at risk for foodborne illness since the established policy cannot guarantee that an entry which may be a "potentially hazardous food" has been properly prepared or handled before, during, or following the competition.

■ Please bring recipe printed or typed on 8½ x 11 paper for judging. DO NOT INCLUDE PERSONAL INFORMATION ON RECIPE. Food must be covered to avoid airborne contamination.

■ All baked goods not handled by the judge or displayed will be sold at the Sweet Tooth Bake Sale following judging.

- Store bought mixes are not permitted in the creation of any recipes except for those in the special cake category.
- All foods MUST be displayed on stiff foil covered cardboard, unless otherwise stated. It MUST be inserted in a re-sealable bag or cake box.

6 cookies on an 8-9 inch stiff, foil covered cardboard.
Bar cookies approximately 1"x2".

► Cake Decorating

Cake forms are required. Display board, cake form, including decorations, not to exceed 24" high.

Cake board not to exceed 18" in diameter.

Frosting recipe required on 8 ½ x 11 sheet of paper.

Description of what each decoration is made of must be listed.

Place each cake on stiff, foil-covered cardboard or cake board.

Cream frostings are not acceptable.

Food Preservation

- Must be in plain, standard jelly glasses or standard canning jars (no salad dressing or peanut butter jars, etc.) with new lids and rings.

- Recipes must be submitted for all food preservation categories printed or typed on an 8 ½ x 11 paper with the exhibit, including processing method, time & temp according to USDA recommendations. Contact the Extension Office for the current USDA canning regulations and head space.

No personal information (name, etc.) on recipe.

- Mark containers with the name of the item and the month and year of processing.

- Food Preservation items must have been preserved within 12 months.

► Jellies

Jelly calls for the strained juice from fresh fruit. The end product has a clear, shimmering appearance.

■ All exhibits must be homegrown by the exhibitor. After judging, exhibits may be freshened at the discretion of the exhibitor. Potted plants should have been potted at least 2-3 months before the fair. Pots/containers are an integral part of judging – they should “fit” the style of plant.

Can be single plant or variety.

There is a three (3) entry limit per section number in this department. No personal vases will be used except in cut flower arrangements.

■ All exhibits must be homegrown by exhibitor. Garden produce should be fully mature. VARIETY OF VEGETABLES ON ENTRY TAG REQUIRED.

This is helpful for judging. Plates for exhibits will be furnished. DO NOT wash or scrub! (Examples of varieties: Big Boy Tomato, Black Beauty Eggplant, Burpless Cucumber, Seneca Daybreak Corn.)

Open Class Activities:

Not only is there a wide variety of competitive classes within the Open Class Exhibit Building, there are also additional activities that exhibitors are encouraged to try including the Bake-A-Rama and Ice Cream Crank Off. Each of these activities has a specific set of rules that participants are expected to acknowledge.

Raspberry Bake-A-Rama:

Get out the recipe books and try that unique new baked creation. Then bring it to the Bake-A-Rama on Wednesday, July 20th at the Marshall County Fairgrounds. Entries will be accepted in the Open Class Building from 9am – 12 noon with open judging beginning at 12:30pm. This year's categories include cookies or bars, cakes, pies, quick breads or muffins and crisps or cobblers. Cash prizes are awarded to 1st, 2nd, and 3rd place winners in each category, as well as the overall Grand Champion and Reserve Grand Champion. Safe food preparation guidelines must be observed.

Stop by the Extension Office today and pick up an entry form that includes all the rules and regulations or visit our website.

Strawberry Cheesecake Ice Cream Crank Off: Each year the Marshall County Dairy Association sponsors a homemade ice cream crank off. This year's crank off will take place on Sunday, July 17, 2022. Check-in is 1pm – 1:30pm, with cranking beginning at 1:30pm. All entrants must be finished by 3pm. Prize money is awarded to the winners. Safe food preparation guidelines must be observed.
