# Simple & Delicious Marry Me Chicken Recipe

Chicken Ingredients:	Sauce Ingredients:	
4 boneless, skinless chicken breasts	1 ½ cups chicken broth	½ teaspoon
½ teaspoon salt	2 tablespoons cornstarch	½ teaspoon
½ teaspoon garlic powder	1 cup sour cream or heavy cream	½ teaspoon
½ teaspoon onion powder	½ teaspoon salt	4 cloves garl
<sup>1</sup> ⁄ <sub>4</sub> teaspoon black pepper	1 ½ teaspoons Italian seasoning	<sup>1</sup> / <sub>2</sub> cup parm
2 tablespoons olive oil	1 tablespoon dried basil	
2 tablespoons butter	1/3 cup chopped sundried tomatoes	, drained
Instructions:		-

- <u>structions</u>: Season the chicken on both sides with salt, garlic powder, onion powder, and black pepper.
- 2. Heat a large skillet over medium-high heat. Add the olive oil and melt the butter.
- 3. Sear the chicken until golden brown. Then take the pan off the heat and set aside.
- 4. Whisk together the chicken broth and cornstarch in a bowl until there aren't any lumps.
- 5. Add the chicken broth mixture to the bottom of an 8-quart crock pot.
- 6. Whish the sour cream or heavy cream, garlic, Italian seasoning, salt, black pepper, red pepper flakes, and paprika.
- 7. Place the seared chicken into the crock pot and pour the olive oil and butter from the skillet on top. Then top each

½ teaspoon red pepper flakes
½ teaspoon paprika
½ teaspoon black pepper
4 cloves garlic, minced
½ cup parmesan cheese



piece of chicken with the chopped sun-dried tomatoes. Place on low for 6-7 hours.

- 8. Take the chicken out and whisk the parmesan cheese in with the sauce in the crock pot. Add the chicken back into the crock pot. Then cover with the sauce and add the basil on top.
- 9. Serve hot on top of pasta or rice with a side of fresh steamed broccoli!

Notes:

- You can skip the searing part, but I think that it adds flavor to the finished dish. If you do skip it, then I would add 4 tablespoons of melted butter to the sauce. The sauce needs the butter/olive oil we pour over the chicken after searing
- Store leftovers in the fridge for up to 3 days. Freeze for up to 3 months.

# 8 Financial Tips for March and April 2024

Managing finances is vital for stability, achieving goals, and reducing stress. It builds wealth, prepares for emergencies, and avoids debt traps. It fosters independence, enables future planning, and ensures a secure future. Ultimately, it empowers individuals to live life on their terms and enjoy peace of mind. Here are a few tips to keep you on track during your financial journey. 1. <u>Educate yourself</u>. Take time these next few months to enhance your financial literacy skills. Try reading books, attending seminars, or listening



to a podcast about investing, budgeting, and/or retirement planning! The more that you know, the better equipped you will be to make informed financial decisions!

2. <u>Review your budget</u>. Take a fresh look at your budget. Does it still align with your current financial goals and priorities this year? If not, make changes!

<u>Activity Worksheets vs Animal</u> <u>Workshops Continuing for 2024</u>

This year we will continue this option for all 4-H animal exhibitors. In the past all of these 4-H members have had to complete their animal species activity sheets and turn them into the Extension Office by July 1. This option is STILL available this year. But we are offering another option: If a 4-H livestock member attends a workshop put on by their specie club this will count in place of those activity sheets. # <u>ATTENTION - Indiana 4-H (QLC):</u> <u>Quality Livestock Care Program</u>

All 4-H youth enrolled in a LIVESTOCK PROJECT (Beef, Dairy Beef, Dairy, Feeder Calf, Goat, Poultry,

Rabbit, Sheep and Swine) must be QLC certified or have a YQCA online completion certificate.

# ATTENTION LIVESTOCK CLUB MEMBERS!!

Some changes to pay attention to: 1. Besides Ear Notching and 840-RFID tags for Swine, and 840-RFID tag and/or 5-digit county tag for Beef and Dairy Beef Cattle, DNA hair samples are required for all Swine, Beef, Dairy Cattle, Meat Goats and Dairy Beef cattle to be eligible for the Indiana State Fair. Collection envelopes and collection instructions are available at the Extension Office. Deadline to return DNA hair samples to the Extension Office by May 15<sup>th</sup> by 4:30 p.m. are the same as the Animal Identification deadline in 4-H Online.

2. It is required that all identification information (ear notch, RFID tag number, breed, gender, etc.) must be provided in 4-H Online and on the collection DNA sample envelope for all animals that you want eligible for the Indiana State Fair. Any of this identification information that are missing, incomplete or incorrect will result in ineligibility to show your animal. If you are enrolled in the 3.

Swine project, be sure you check the ear notches carefully! When purchasing your pig(s), make sure the ear notches match the papers you receive. Do not assume the notches match the paper! If you put the notches in yourself, be sure you put the notch in the correct location of the ear. After the May 15th animal identification deadline, ear notches cannot be changed, corrected or substituted.

4. ALL Dairy Cattle are required to have an 840-RFID tag in which to be eligible for 4-H shows and at the Indiana State Fair. This tag will need to be entered along with other required information in 4-H Online by May 15<sup>th</sup>. Any of these IDs that are missing, incomplete or incorrect will result in ineligibility to show your animal.

5. ALSO FOR 2024!

**RABBIT:** Animal identification for Rabbits will be completed in 4-H Online. There will be no forms available.

**SWINE:** 4-H'er may bring 6 animals – **YOU MUST HAVE BOTH GENDERS!** For example: 3 barrows and 3 gilts, 4 gilts and 2 barrow, or 4 barrows and 2 gilts, etc.

6. Poultry Animal Identification Enrollment Forms are due by May 15<sup>th</sup> at the Extension Office! Forms are available at the Extension Office or on the Purdue Extension Whitley County office website.

# Premise ID Info

Anyone who buys, sells or exhibits livestock must have a Premise ID. A

Premise ID is an identification number for the physical location in which animals are housed and is necessary to protect animal agriculture and the livestock industry. In an emergency, animal health officials will be able to rapidly communicate disease spread with producers. All 4-Hers are required to know the Premise ID number for the property in which their animals are located and this number is recorded in 4-H Online when enrolling the animals to be exhibited at the 4-H Fair and Indiana State Fair.

If you own a horse, you can inquire for a Premise ID number, but it is not required to exhibit.

If you do not currently have a premise ID number, you may apply for one through the Indiana State Board of Animal Heath at http://www.in.gov/boah for the quickest response or call (317) 544-2400.

You MUST have a premise ID to show at the Whitley County 4-H Fair and the Indiana State Fair for cattle, swine, goats and sheep.

# Invasive Species Awareness Week is Feb. 26 - March 3

Invasive insects, plants, and other organisms are challenging our natural areas by out-competing or decimating native populations. This impacts native plants, insects, birds, fish, and wildlife. Control efforts are expensive and timeconsuming.

The most recent incursion of note is the finding in 2022 of spotted lanternflies (SLF) in nearby Huntington, IN. I have heard of other rumored sites in Indiana, but they haven't been officially reported by Indiana DNR.

See the pictures below of SLF insects at the Huntington location in 2023.

To spread, the pest seems to be taking advantage of hitchhiking on railroad cars via egg masses, especially at sites where the cars may remain stationary for extended periods. They can also be moved via other moving vehicles. Some limited natural spread also occurs.

Penn State University reports that While SLF feeding can stress plants and cause localized branch damage, it is not known to kill plants except for grapevines, tree of heaven, and black walnut saplings. However, it has been found on over 100 species of plants, and PSU reports that the spotted lanternfly uses its piercing-sucking mouthpart to feed on sap from over 70 different plant species.

It feeds on sap from the stems or leaves of plants, weakening the plant overall. The honeydew they produce covers the ground, attracting ants and wasps, and it grows a sooty mold on the surface of the honeydew. If you see it, report it. It's important to note that not all nonnative species are bad – some behave themselves just fine in our environment.

For species that don't behave, local residents can report invasive species by calling the Invasive Species hotline at 1-866-NO-EXOTIC (1-866-663-9684) or using the free Great Lakes Early Detection Network smartphone app, which can be downloaded on iTunes or GooglePlay. will focus on emergency preparedness for rural families. I'm working closely with Amy Biggs, Whitley County Emergency Management, to offer this program. The program is a collaboration between extension Women in Agriculture programs at Purdue University and the University of Nebraska-Lincoln.

The program will be a 4-part series, held locally at 524 Branch Court, Columbia City, IN. The series will focus on farm and ranch emergency management, first aid, fire protection, and hazardous materials. Workshops will be held from 5:30 to 8:30 p.m. Eastern time on March 5, 7, 12 and 14. Other regional host sites include Angola and Plymouth, IN.

Each state will host several workshop sites with local extension personnel. Keynote speakers will be simulcast to each location, and each site will provide additional speakers and hands-on activities. A simple dinner will be included at the beginning of each session.

The program's structure is intended to strengthen networks of women in rural areas, which can provide opportunities for building trust and sharing information. Men are also welcome.

The workshops seek to help participants initiate preventative practices, set up a plan to deal with emergencies before they occur, and be more comfortable reacting to emergencies.

There is a registration fee of \$50 per person before Feb. 20. The fee increases to \$60 per person after Feb. 20. Participants should plan to attend each session. A virtual option is available for those unable to attend a workshop site, although in-person attendance is highly encouraged to better network with other attendees and interact with speakers. # Highlights of Recent Agricultural Production

Where did Whitley County rank recently in corn production among all other Indiana counties? What was a recent state-wide yield for soybeans? These and other questions are addressed in the annual Indiana Agricultural Statistics Bulletin, 2022-23, recently posted online. If you are interested in a paper copy, we have a few available free of charge in the Whitley County Extension office.

According to the 2022-23 Indiana Agricultural Statistics bulletin for average crop yields in Whitley County in 2022 (most recent data available), corn came in at 186.7 bushels per acre, soybeans were 54.6 bushels per acre, and wheat was 75.5 bushels per acre.

Among all Indiana counties for crop production in 2022, Whitley County ranked 41st in corn, 45th in soybeans, and 9th in wheat. For livestock production, Whitley County ranked 54th in the number of beef cows, and 30th in the number of milk cows (as of Jan. 2023).

Total ag receipts in Whitley County in 2021 totaled \$162.993 million, with crops contributing \$108.996 million, and livestock contributing \$54.027 million.

2021 realized net income (total income minus total expenses) to Whitley County farmers was \$58.121 million. This net was \$36.7 million in 2020, \$30.3 million in 2019, almost \$7.1 million in 2018, almost \$8.6 million in 2017, and just less than \$13.40 million in 2016.

From the 2017 USDA Ag Census, Whitley County ranked 13th in all hogs, 56th in all sheep, 28th in chickens, and 57th in turkeys. Of the 214,764 total acres in Whitley County, 176,255 of those acres were in farms (2017 Census of Agriculture). 154,095 acres were in cropland, 3748 acres were pastureland, and 10,252 acres were woodlands. There were 696 Whitley County farms in 2017, with an average size of 253 acres/farm.


